
NEW CRANE INFORMATION LEAFLETS

- CRANE has updated its [information leaflets](#) for the cleft community.
- There is now one main leaflet for families, which includes data linkage details.
- The leaflet is shorter, clearer, more accessible, patient-focused, and approved by CAG and CLAPA.
- Due to **nation-specific legal differences**, use the correct leaflet for your country.
- Share the leaflet with families shortly after diagnosis; do not use old versions.
- The leaflet can be printed or accessed via QR code.
- A new consent form is also available on our website.

2025 PALATE EXAMINATION GUIDE

The Royal College of Paediatrics and Child Health published the updated 2025 '[Palate examination: Identification of cleft palate in the newborn - best practice guide](#)'. One of the key recommendations states that

'Trusts should provide training on the correct method of visual inspection of the palate to all healthcare professionals required to carry out the NIPE.'



CRANE DATABASE UPDATES

- **Birthweight** and **gestational age** data items can now be submitted for *all* children in England and Wales, not just those with consent. This is based on approval from the Confidentiality Advisory Group (CAG).
- 5-year-old index scores will now be accepted for **complete bilateral cleft lip and palate** (LAHSAL) cases. Retrospective data can be submitted using imports.
- New psychology **CLEFT Q** and **TIM** tabs will go live in the Spring so that scores, obtained at 10 years, can be submitted.
